

# Green Infrastructure for Stormwater Management 2017

Recently the Lake Champlain Basin Program and Watershed Consulting Associates developed a manual on using Green Infrastructure (GI) for stormwater management for municipal officials in New York's Lake Champlain Basin. The manual covers implementation of GI in environments typically encountered by municipalities – village (developed) streets, rural roads, parking lots and hardscapes, and buildings. The manual also discusses planning and implementation, operation and maintenance, and how to get your project funded.
