The New York Citizens Advisory Committee on Lake Champlain Management supports the Vermont and Québec Citizens Advisory Committees (CAC) recent request for the governments of Vermont and Québec to present to the public pursuant to Article 3.3 of the Agreement, the evaluation and reporting methods, and share progress on the monitoring, source load reduction, and best management practices implemented in the watershed, in addition to planned actions and progress made towards reaching the goals of the agreement between Québec and Vermont concerning phosphorus reduction in Missisquoi Bay.

Given the tri-jurisdictional nature of Lake Champlain, there is much interest from the public on actions undertaken by the Parties pursuant to the Agreement in the Missisquoi Bay watershed and impacts from efforts to reduce phosphorus loads and restore the integrity of the ecosystem.

Therefore, the New York CAC echoes the Vermont and Québec CACs' request that both the ANR and MELCCFP should make public presentations on both sides of the border before July 1st, 2023, and every year thereafter; in addition to their LCBP reporting requirements pursuant to Article 4(d).
