Denise shared an idea to host an action plan rollout event with legislators from the Lake Champlain Basin who may not be on the committees the CAC normally presents to but to whose constituents the content of the action plan is relevant. Members were supportive of doing the rollout as part of the November 13<sup>th</sup> meeting and including the flood impacts presentation on the agenda.

- Bob suggested reaching out to Sen. Welch, Sen. Sanders, and Rep. Balint as well.
- Wayne suggested inviting some press to the event.
- Lori noted the CAC should think about how this impacts the legislative roll out of the Action Plan.

- Wayne added that in addition to engaging the legislators, part of the goal of an earlier roll out of the Action Plan is to influence the State's budget priorities that are announced in January which means getting the plan in front of Secretary Moore and the Governor earlier.
- Denise, Lori, and Carol volunteered to work on planning the in-person event for the November 13<sup>th</sup> meeting.
