# 2026 Education and Outreach Small and Large Grants Request for Proposals

### **Purpose**

Support efforts to enhance the knowledge and understanding by members of the public, including children and adults, of the water quality and ecosystem health issues identified in *Opportunities for Action* and/or foster informed decision-making, individual action, and behavior change that will benefit Lake Champlain.

### **Funding Sources**

This grant opportunity is supported by funds anticipated to be awarded to NEIWPCC by the U.S. Environmental Protection Agency on behalf of the Lake Champlain Basin Program, and in partnership with the Great Lakes Fishery Commission.

### **RFP Details**

### **Small Education and Outreach Projects**

- Up to \$15,000
- \$180,000 available funding
- One proposal per eligible organization
- Proposals are due December 15th, 2025 at 5:00PM

### **Large Education and Outreach Projects**

- \$15,000 \$50,000
- \$400,000 (approximate) available funding
- Two proposals per eligible organization
- Proposals are due January 5th, 2026 at 5:00PM

- ! Email submissions not accepted
- ! Applicants currently holding LCBP/NEIWPCC contracts must be in good standing.

## **Evaluation Criteria (E&O Small)**

**Impact (40 points)** Extent to which the project will inform members of the public about Lake Champlain issues, specifically topics that advance objectives and strategies identified in Opportunities for Action (2022 edition), encourage stewardship actions by citizens, and/or reaches new audiences.

**Likelihood of Success (20 points).** Extent to which objectives and tasks are well defined, support the project concept, and are feasible within the proposed schedule. Outputs should demonstrate task completion.

**Organizational capacity of project team (20 points).** Knowledge and experience with education and outreach initiatives related to the Lake Champlain basin, and the capacity of the applicant to successfully complete the project.

**Budget (10 points).** Appropriateness and clarity of the task-based budget and budget justification, relative to project scope and outputs. Non-federal in-kind or cash match is not required, though match will be considered favorably during budget review and may make proposals more competitive.

**Evaluating Success (10 points).** Extent to which the project includes evaluation and reporting on the success of the work included in this grant in terms of increasing knowledge and/or effecting personal action or behavior change.

# **Evaluation Criteria (E&O Large)**

**Impact (40 points)** Extent to which the project will inform members of the public about Lake Champlain issues, specifically topics that advance objectives and strategies identified in Opportunities for Action (2022 edition), encourage stewardship actions by citizens, and/or reaches new audiences.

**Likelihood of Success (20 points)** Extent to which objectives and tasks are well defined, support the project concept, and are feasible within the proposed schedule. Outputs should demonstrate task completion.

**Organizational capacity of project team (15 points)** Knowledge and experience with education and outreach initiatives related to the Lake Champlain basin, and the capacity of the applicant to successfully complete the project.

**Budget (10 points)** Appropriateness and clarity of the task-based budget and budget justification, relative to project scope and outputs. Non-federal in-kind or cash match is not required, though match will be considered favorably during budget review and may make proposals more competitive.

**Evaluating Success (10 points)** Extent to which the project includes evaluation and reporting on the success of the work included in this grant in terms of increasing knowledge and/or effecting personal action or behavior change.

**Community Need (5 points)** Extent to which the project addresses a community-identified need for education and outreach around the topic, a particular audience, of form of outreach or communication.

- A travelling, interactive spatial and geographical learning tool for teachers and students.





- + Applicants must conduct their work within the Lake Champlain Basin.
- + Eligible applicants include:
- Colleges and universities
- Nonprofit organizations
- NY Soil and Water and VT Natural Resource Conservation Districts
- Non-federal/non-state government agencies, including municipalities
- + Organizations can apply for both categories

#### **Metrics**


- Reporting metrics track deliverables and assess project reach/success

- Receipts ≥\$1,000 for supplies or professional services
